



What are the experiences of patients & partners of patients with a life-limiting illness in relation to sexuality and intimacy?

- Heideggerian hermeneutic phenomenology
- 2 interviews
- MND (also terminal cancer)
- 13 Patients: 8 male, 5 female
 Aged 46 82 years
- 10 partners: 5 male, 5 female
 Aged 32 76 years

A role for health care professionals?

Ex-PLISSIT: The Extended PLISSIT Model

- Permission
- Limited Information
- Specific Suggestions
- Intensive Therapy
- Reflect
- Review

Just some examples...

Permission-giving

Sometimes people with MND have concerns or questions about how this will affect their sexual relationship. Is there anything you'd like to ask me or talk about?

Limited Information

Having a hospital bed provides many advantages. However, it may also have an impact upon your relationship as a couple

... follow with further permission-giving

Specific Suggestions

- Alternative ways of showing love & affection
- Sign language for 'I love you'



ALS Functional Rating Scale (ALS FRS)

(Haverkamp et al, 1995)

- Speech
- Saliva
- Swallowing
- Handwriting
- Cutting food & handling utensils
- Dressing & hygiene

- Walking
- Climbing stairs
- Breathing
- Turning in bed & adjusting bed clothes



Take home message



- Equipment can impede verbal and physical intimacy
- Addressing sexuality is essential if we are to provide holistic care
- We need to reflect on barriers that prevent us from doing this and give people permission to talk about this important part of their relationship
